Minutes of the meeting of the Council held at the Eight Ash Green Village Hall, Spring Lane, Eight Ash Green on Wednesday 12 October 2022 at 7.30pm.

There were ten members of the public in attendance.

51-22/23 To receive Apologies for Absence and confirm acceptance of those apologies

There were no apologies to receive.

52-22/23 Declaration of Interests

There were no Declarations of Interest.

53-22/23 Public Participation

Mr John Allcock referred to the Eight Ash Green Neighbourhood Plan and asked the Parish Council's view on the development with reference to the Plan. He said the development so far seemed to be in line with the requirements of the Plan.

He asked about the road junction from the development with Halstead Road.

The Chairman said the T-junction was a priority junction. He said for the moment the developers were continuing with this while looking at options including signage. He said once the road was open, the Parish Council could contact local companies using the road to advise on the preferred HGV route.

Mr Allcock asked about the provision of bus stops.

The Chairman said the Parish Council were still pushing CBC on this issue. He said Essex County Councillor Lewis Barber was pursuing the provision of two stops.

The Chairman said complaints regarding noise seemed to have settled down.

A resident referred to the Village Hall and said he had cleared a tree as requested but that there was still a problem with a fence on the hall boundary.

Cllr Bilby said the Village Hall Committee would replace the fence.

Cllr Nokes said that this issue was between the resident and the Village Hall committee.

Mr Tim Chambers said that the Cricket Club had enjoyed a good season. He said the Club had been awarded a Tackling Climate Change award which had been presented by Graham Gooch. He said the groundsman had reported an increase in dog fouling from September which seemed to be a common problem each year.

54-22/23 To agree as a true record the minutes of the meeting of the Parish Council held on Wednesday 13 July 2022

The minutes of the meeting of the Parish Council held on Wednesday 13 July 2022 were **agreed** as a true record and signed by the Chairman.

55-22/23 Report from the County and Borough Councillors: Report from County Councillor and Ward Councillors, if present.

Cllr Christine Willetts said that Cllr Dennis Willetts was attending a meeting at the Borough Council but hoped to arrive shortly.

56-22/23 To review the Council's Action Tracker and to note any action necessary.

The Council's Action Tracker was reviewed. Cllr Jardine said an updated Tracker would be circulated by the Clerk following the meeting.

Cllr Morgan said she had noticed the problem had increased recently. She said there was a Public Space Protection Order in place across the borough but no measures taken so far seemed to work. It was noted a further appeal would be put on Facebook.

Cllr Nokes said new litter bins for the Play Area should be added to this list.

d) Update on Village Hall project

Cllr Bilby said following discussion with CBC Planning Officers the Hall Committee would be submitting amended drawings with changed elevations.

57-22/23 To agree the Parish Council response to planning applications received from Colchester Borough Council and to note decisions made on previous applications

221870 - Eight Ash Green Village Hall, Village Hall, 25 Spring Lane, Eight Ash Green Essex CO6 3QF - Demolition of existing hall (202m²) and replacing with new hall 272m². New hall to be positioned further back on the existing site making better use of redundant land to the sides and rear to increase off street parking

It was **agreed** that there was no objection to this application, with nothing included contrary to the Village Design Statement. It was noted that amended drawings were to be submitted.

221871 - Eight Ash Court, Halstead Road, Eight Ash Green Colchester CO6 3QJ - Conversion of 2no. 6 bedroom care home bungalows into 8 self-contained units providing supported living services for people with learning disabilities

It was **agreed** there was no objection to this application, with nothing included that was contrary to the VDS or the Eight Ash Green Neighbourhood Plan. Concern was noted regarding the floor plan and lack of accommodation for carers and the potential for parking issues given the number of units involved.

222097 – Little Maltings, Little Maltings Farm, Abbots Lane, Eight Ash Green, CO6 3QL – Construction of a new single storey office building

It was **agreed** that there was no objection to the provision of an office on this site. It was also noted that the site was outside the village envelope and that CBC should consider that residential use for the building should not be granted at any point in the future and that the office should only be sold as part of the main building.

222284 – Land at Eight Ash Green Dental Surgery, Halstead Road, Eight Ash Green, CO6 3QA – Outline application with some matters reserved – erection of a residential development comprising 9 units with associated parking and relocation of parking facilities for the retained dental practice

It was **agreed** to comment as follows:

“Eight Ash Green’s Neighbourhood Plan was recently adopted by CBC. There was a “call for sites” to landowners within the village, who wished to apply to develop their land for residential use. The site which is the subject of this planning application was not submitted, and therefore not considered by the village residents.

This site has just over 1/3 of its area within the settlement boundary, and the balance lies outside it. Therefore any development outside the boundary would be contrary to our NP.

The area for future housing in the village was decided by our residents through multiple consultations, who specified there should only be one strategic site for residential development within the village to meet CBC’s housing needs of 150 dwellings. This is the Fiddlers Field /Aspen Walk development.

The properties within our new housing development contain a complete mix of housing for local needs as specified by our village. There is no need for additional ad hoc development.

The villagers stressed that piecemeal building throughout the village should not be permitted, and strong opinions were expressed that the settlement boundary should not be extended any further as 150 extra dwellings already increased the size of the village by about 20%. All of these comments were incorporated into our approved NP.

The site which is the subject of this application is situated adjacent to a large open field which is also outside the village settlement boundary but which was however submitted under the “call for sites” strategy. This site was completely rejected by the village who wished to retain the open airy aspect

within the village centre, and this request was duly incorporated into the NP. Development encroaching towards this open area would be contrary to that wish. Approval of the above application would be regarded by the village that the settlement boundary could easily be extended against their wishes, and this planning application was just the starting point.

Approval of any application to develop a site outside the village settlement boundary would be an open invitation for any developers to follow suit which would be completely contrary to our NP.

The settlement boundary exists to protect the village from such piecemeal development, and no breach should be allowed which would create a dangerous precedent and give rise to ribbon development or urban sprawl, both of which are also contrary to our NP.

The NP specified that all new housing within the village should be low-medium density to be compatible with the open aspects of the surroundings and the character of the village. The outline drawings on this application show several properties squashed onto the site giving a very cramped appearance in an area immediately adjacent to the previously mentioned large open field. This over development is totally out of character with the surrounding rural area and so also contrary to our NP.

There is a bus shelter to the immediate west of the site of this planning application so sightlines are limited, and a pedestrian crossing a few metres towards the east. Spring Lane to the east and Blind Lane almost opposite form a "crossroads" on a tight bend in the road with very limited visual display from all directions. Up to 18 vehicles egressing the site in the morning rush hour will create severe concerns for everyone's safety.
